## INVITATION FOR EXPRESSION OF INTEREST FOR DESIGNING THE PUNJAB POLICE INTEGRATED COMMAND AND CONTROL CENTRE (IC³)

Government of The Punjab, Police Department, intends to hire services of technical consulting firm(s) for preparing a detailed design of its IC3 project. The design would ensure integration of the IC3 with existing control centres, crisis management, preparation of tender documents and PC-1 of IC3 project. In this regard expressions of interest are invited from suitable consultancy firms / organizations to develop a detailed technical and operational design for the Integrated Command and Control Centre (IC3) environment, and to prepare Tender Documents and PC-1 which would enable the Punjab Police to procure services of a system integrator to deliver the IC3 systems and capabilities.

- Demonstrable track record of delivering transformation programmes.
- In-depth knowledge of police command and control processes.
   Experience working with senior police offices and other senior stakeholders.
- Knowledge of local policing environment in Puniab.
