**AMENDMENTS**

In Standing Order No.10/2023 "Maintenance and Administration of Band Staff in Punjab Police:

1. **In Rule – 18**, under head "Promotions", the following amendments have been made:

For Head Constable	<p>b. Band Recruitment Course shall be exempted for those Constables who have completed 10 years' service as Constable.</p> <p>c. Regular performance evaluated at 10 official functions in one year shall be regarded as a skill set. 50 new tunes / music scores (needed for these functions) shall be performed and evaluated by a committee headed by IGP, Punjab and special course meant for each category/field/skill may be waved.</p> <p>e. Punishment criteria shall be as prescribed in Standing Order No.10/2017 regarding promotion of Constable to IP (G.E.B) will be followed.</p>
For ASIs	<p>b. Regular performance evaluated at 10 official functions in one year shall be regarded as a skill set. 50 new tunes / music scores (needed for these functions) shall be performed and evaluated by a committee headed by IGP, Punjab.</p> <p>c. Special course meant for each category/field/skill may be waved.</p> <p>d. Punishment criteria shall be as prescribed in Standing Order No.10/2017 regarding promotion of Constable to IP (G.E.B).</p>
For SIs	<p>b. Regular performance evaluated at 10 official functions in one year shall be regarded as a skill set. 50 new tunes / music scores (needed for these functions) shall be performed and evaluated by a committee headed by IGP, Punjab.</p>
