


AUCTION NOTICE OF USED MOBIL OIL

Rs. 44,583/- 03% of estimated price (Refundable). Bank Draft/Pay Orders/CDR for the said both fees shall be in the name of SSP/Admin CTD HQ Punjab, Lahore. TERMS AND CONDITIONS

1. Offers / Rates should be quoted per liter (including taxes) as contained in Annexure-A.
2. The successful Applicant shall be bound to lift used Mobil Oil from CTD HQ, Punjab, Lahore at its own expenses.
3. All applicable taxes shall be deposited by the successful Applicant in addition to quoted rates before lifting the used mobil oil.
4. Offer must accompany the copy of CNIC & NTN certificate.
5. Offer / rates to be valid up to 30-06-2024.
6. Security Deposit amounting to PKR Rs.44,583/- (03% of estimated price) in shape of Bank Draft/Pay Order/CDR refundable (in favour of SSP Admin CTD HQ Punjab, Lahore) must be attached with offer, otherwise, offer will be rejected (Cheques/Cash will not be acceptable as security deposit).
7. Offer without security deposit will not be accepted.
8. The security deposit of successful Applicant will be retained as Performance Guarantee and will be released after completion of the work satisfactorily.
9. Performance guarantee will be forfeited, if the qualified Applicants fail to lift the used mobil oil within fifteen (15) working days after announcement of successful applicant name.
10. Successful Applicant shall be bound to lift the used mobil oil as per quoted/approved rates.
11. The Applicant shall provide an affidavit on Rs.100/- stamp paper that applicant has not been black listed from any Ministry/Division/Department/Organization.

13. Sealed offers should reach office of the Counter Terrorism Department Headquarter Punjab, Lahore by 22nd November 2023 at 11:00 AM to be opened at 11:30 AM in presence of desirous Applicant(s).
14. Successful Applicant shall bound to deposit auction amount within 3 working days from

the date of auction.

15. Failing to deposit auction amount by the successful Applicant within prescribed time period may lead to forfeit of its Security and strict legal action will be taken against participant.
16. All taxes will be applicable as per Govt of the Punjab rules and regulations. Applicant shall be self-responsible for deposit of all provincial and federal taxes which are applicable.
17. Highest per liter rate given by an Applicant at the time of auction will be accepted.
18. Used Mobil Oil to be auctioned should be carefully examined by the Applicant prior to participate in the auction process.
