- 4. The physical measurement and endurance test of those candidates who have applied on more than one posts (PHP, SPU & district Police) shall be conducted once for all.
- 5. The concerned districts/unit shall ensure the availability of measuring tape and height measuring scales as well as other necessary equipment during the physical measurement.
- 6. Suitable venue shall be selected for endurance test and driving test which will be held as per schedule mentioned above.
- 7. The endurance test (01 mile) should not be conducted at odd hours to avoid hardship to the candidates and may be carried out in early hours of morning or in the afternoon. Availability of ambulance / Rescue 1122 teams along-with necessary first aid equipment/medicines and doctors during the endurance test as well as at the venues of physical measurement must be ensured. Adequate supply of drinking water for the candidates must be ensured at the starting point of the race, in the middle and also at finishing point of the race.

- 8. Concerned CCPO/CPOs/DPOs will make appropriate lodging and logistic arrangements for Chairmen & members of the recruitment board during the entire recruitment process.
- 9. In order to eliminate any chance of impersonation and to ensure transparency and merit in recruitment process, verification of candidates must be carried out through Bio-metric devices during the process of physical measurement, endurance test, written test and Interview.
  - 10. Extreme vigilance and strict security measures should be taken for the venues of recruitment to avoid any untoward incident. A proper security order should be issued accordingly under intimation to this office.
    - 11. <u>Moreover, during the entire recruitment process, COVID-19 SOPs</u>
      of Federal as well as provincial Governments, ensuring wearing of face mask
      and use of sanitizer shall be strictly followed in letter & spirit.
