Enclosed please find a copy of letter bearing No. 1/4/2023-UN, dated 06.06.2023 received from the National Police Bureau (NPB), Ministry of Interior, Government of Pakistan, Islamabad, on the subject matter.

2. In pursuance of above said letter of the NPB, MOI, Government of Pakistan, Islamabad, a Provincial Selection Team under the chairmanship of Mr. Khurram Shahzad Haider (PSP/BS-20), Dy. Commandant, Punjab Constabulary, Farooqabad has been constituted for conducting tests at provincial level.

3. CCPO Lahore, RPOs, and all heads of Police Units are requested to furnish nominations of only eligible candidates who meet the criteria given in the attached letter of NPB, directly to the chairman of the Provincial Selection Team under intimation to this office. The deputationists will apply through their parent units through proper channel.


4. Provincial tests will be held at the Punjab Constabulary Headquarters, Farooqabad. Arms/Ammunition for firing tests at provincial level will be provided by the Addl. IGP, Logistics & Procurement, CPO, Punjab from the CPO Arms/Ammunition Store, Farooqabad, on written requisition by chairman of the Provincial Selection Team.

5. The timelines for nominations and screening, etc, are as under;
- Submission of nominations by CCPO/RPO/heads of units to Chairman Provincial Selection Team upto 12.06.2023 on the following address under intimation to this office:

  - Scrutiny of applications by the Provincial Selection Team from 13.06.2023 to 14.06.2023
  - Screening test by the Provincial Selection Team from 15.06.2023 to 17.06.2023
  - Final merit list alongwith result will be furnished to Central Police Office, by chairman of the Provincial Selection Team on 18.06.2023.

Subject: SELECTION ASSISTANCE AND ASSESSMENT TEAM (SAAT) VISIT TO PAKISTAN – JULY 2023

I am directed to refer to the subject cited above and to state that Military & Police Adviser, Pakistan Mission to United Nations at New York have informed that UN SAAT will be visiting Pakistan during July 2023.

2. The Pakistan Mission to the United Nations has further directed that for SAAT test in July 2023, the total number of candidates shall not exceed 200 IPOs with 50 IPOs as reserve (IPOs must include 20% female candidates). The final / consolidated list of candidates (strictly as per UN Police Division's format) needs to be shared well in time before the SAAT visit for inserting data in the respective system.

3. The required list of 200+50 slots is distributed as per detail given below:

4. In view of above, it is requested that **nominations of candidates** should be forwarded to this office before **20-06-2023**. The Heads of all police organizations are requested to ensure **driving, shooting, English language and medical fitness** of all candidates.


5. The opportunity is open to all ranks (**Only uniformed personnel**) fulfilling the following criteria:

- i. Have a minimum of five years of service.
- ii. Should not be under disciplinary proceedings.
- iii. Be in possession of a valid motor car / Jeep driving license.
- iv. Should be 25 years or above on the date of the UN (SAAT) Test.
- v. Should be cleared by a medical board.
- vi. Should have basic computer knowledge.
- vii. Should be security cleared by the I.B or Special Branch.
- viii. Must have command over English language (spoken & written).
- ix. Officers on deputation can apply with the concurrence of both the lending and borrowing organizations.

Lists with incomplete information or received after the deadline will not be processed / entertained. Due to paucity of time list received earlier shall be considered as final list.
